### 5. Activity Report of Board of Directors for 2022/2023 (PB)

- Introduction of the Board of Directors by PB
- Membership overview by Haley Lu: 2022 resulted in a lower membership count, due to the lockdown and zero-covid measures.
- Event overview by Nicole Sham: 93 events and trainings in 2022; 25 offline, 57 online events, trainings scope expanded.
- There was a drop in attendance in 2022 due to COVID impact which gradually picking up in 2023.
- Wechat followers increased 23% year-on-year

# 6. Treasurer's Report and Auditor's Statement (NC)

- Introduction and overview presented by NC
- 2022 was a challenging year but maintained the 2019 levels.
- In 2022: 1.4m for membership fees which is 7% less than 2021. Swiss ball remains the biggest turnover driver which was not organized in 2022 due to COVID policy. This led to 60% less turnover than in 2021.
- 33% down on total expenses due to reduction in event expenses and Bridge magazine go online etc.
- SwissCham received official auditor's statement for 2022.
- Treasurer report and auditor's statement are approved by the members by acclamation.

### 7. Discharge of the Board

• SB, as President-of-the-day, asks the members to agree to discharge the Board. The members approve.

### 8. Election of New President LR and Board Member Ivy Yang

- Lucas Rondez as President and Ivy Yang as Board member are elected and confirmed
- As per last year's change of the bylaws, Board elections are held every two years. The next one is organized in 2024.

### 9. Outlook annual program 2023 (LR)

- Board responsibilities to understand the needs Members and provide support
- Strengthen the communication with governments both Swiss and Chinese governments
- National coordination: more coordination with different chapters in BJ, GZ etc. to support members geographically
- More personal communications with Swiss member companies by regular visiting
- Create working groups and committees that are open to members

### 10. Budget 2023 (NC)

- NC introduces the budget proposal. Membership fees 1.5m which is slightly increased from 2022. Main events income: Swiss Ball. Expense 9% increase on personnel cost; event expense increase due to Swiss ball; general administration expenses increase 14%; overall 34% increase on total expenses.
- The budget 2023 is approved.


