SSEF: A BRIEF HISTORY



2010

On the occasion of the **60-year anniversary** of the Sino-Swiss diplomatic relations, the former **President and former Federal Councillor, H. E. Mrs. Doris Leuthard** attended the forum and expressed her strong confidence in the Sino-Swiss economic relations.

2012

Federal Councillor, H. E. Johann Schneider-Ammann continued to enforce economic relations, since in 2011 the two countries launched negotiations for the first **Free Trade Agreement (FTA)** between China and a European country.



2014

Focused on "**Quality, Innovation, Competitiveness, Sustainability**", four panel discussions were organized with the presence of the State Secretary for Economic Affairs, **Mrs. Marie-Gabrielle Ineichen-Fleisch**, and Chinese Minister of Commerce, **H.E. Mr. Zhong Shan**, to celebrate the entry into force of the FTA between Switzerland and China.

2016

On the occasion of the **official State Visit of the President of Switzerland H. E. Johann Schneider-Ammann**, it was time to underline the importance of innovation and connectivity. In the center of the discussions lay the newly introduced **One Belt One Road Initiative and innovation**, as Switzerland ranks no. 1 on the list of the most innovative countries of the world for many years.



2018

The 5th edition was held during the official visit of **Federal Councillor Johann N. Schneider-Ammann** and in the company of economic and science delegations concentrating on **free trade today and in the future**.



2020

To celebrate the 10th anniversary of this flagship event, this edition outlined robust and prosperous economic Sino-Swiss relations as well as lucrative bilateral trade and strong business ties, which aimed to foster a dialogue on sustainability - "**Together for a better future - smart & sustainable**".



2023

The 7th edition explored how to form competitiveness through **vocational and professional education and training (VPET)**. The China-Switzerland Alliance on Vocational Education was officially launched at this event.

2024

The 8th Sino-Swiss Economic Forum: **Shaping the Future of Collaboration and Innovation**; with the presence of **Federal Councillor, Head of the Federal Department of Economic Affairs, Education and Research, H.E. Guy Parmelin** and **H.E. Mr. Wang Wentao, Minister of Commerce, the People's Republic of China**

2026 SSEF SUB-FORUM TOPICS

The following topics will be discussed during the 2026 SSEF sub-forums.



LIFE SCIENCES

Specific topics related to life sciences will be discussed within the Life Science board of representatives, and the topics will be based on the most recent issues in the life sciences sector in China.



HUMAN RESOURCES

Proposed topics include the impact of AI on human resources, how HR professionals can prepare for the AI era, and how AI is impacting organizations from an HR stand points. Besides, the DISC personality assessment may also be discussed.



ADVANCED ENGINEERING AND MANUFACTURING

The proposed topic will explore the transition from Localization 3.0 to Localization 4.0. While Localization 3.0 focuses on establishing research and development capabilities in China, Localization 4.0 highlights China's role as a global innovation and supply chain hub serving markets worldwide.



RETAILS

Proposed topics may include strategies for cost reduction and efficiency improvement through precise marketing, regulatory developments related to the Advertising Law. The discussion may also address how to align with national policies aimed at stimulating consumption, including government subsidy programs.



INNOVATION

Topics will be discussed with the Innovation Committee, focusing on how companies manage the innovation cycle within their internal processes, how organizations foster innovation, and how perceptions and approaches to innovation may differ between Chinese and Swiss companies.



AI DIGITALIZATION

This sub-forum will explore the latest developments in artificial intelligence and digitalization and their impact on business transformation. Topics may include emerging trends such as AI agents, generative AI applications in enterprises, and practical approaches for integrating AI into business operations.

Guest speakers will provide expert analysis and interpretation of key topics, delivering insights tailored to the needs of C-level executives.

生命科学

生命科学领域的具体议题将由生命科学委员会进行讨论，相关议题将基于在华生命科学行业当前最新的发展动态与关键问题展开。



人力资源

拟讨论的议题包括人工智能对人力资源领域的影响、人力资源专业人士如何为人工智能时代做好准备，以及人工智能从人力资源角度对组织产生的影响。此外，还可能讨论 DISC 性格测试在人力资源领域中的相关议题。



先进工程与制造

拟讨论的议题将探讨从本地化 3.0 向本地化 4.0 的转变。本地化 3.0 主要指在中国建立研发能力，而本地化 4.0 则强调中国在全球创新与供应链体系中的关键角色，使中国的供应链不仅面向本地市场，也成为面向全球市场的重要枢纽。



零售行业

拟讨论的议题包括通过精准营销实现降本增效的策略，以及与相关法规的监管政策动态。议题还将探讨企业如何与刺激内需的政策相结合，包括政府补贴等相关措施。



创新

相关议题将与创新委员会共同讨论，重点关注企业如何在内部流程中管理创新周期、如何推动组织内部的创新发展，以及中瑞企业在创新理念与实践方法上的差异。



人工智能与数字化

本分论坛将探讨人工智能与数字化领域的最新发展及其对企业转型的影响。议题将包括 AI Agent 等新兴趋势、生成式人工智能在企业中的应用，以及将人工智能融入企业运营的实践路径。
